O PROHIBITED ARTICLES

- (1) Narcotic drugs, stimulants, marijuana, psychotropic substances, MDMA etc.
- (2) Firearms such as Pistols, revolvers and machine guns, and bullets or parts thereof.
- (3) Explosives (dynamite etc), materials for chemical weapons.
- (4) Counterfeit, altered or imitated bank notes, coins or securities, and forged credit cards.
- (5) Obscene or immoral materials, and Child pornography.
- (6) Articles which infringe upon intellectual property rights. (patent, utility design, trademark, copyright, neighboring right, etc.)

RESTRICTED ARTICLES

- (1) Hunting guns, air guns, swords, etc.
- (2) Internationally protected endangered animals, plants, or their products.
- (crocodiles, Cobras, Turtles, ivory, musk, cactus, etc.)
 (3) Live animals and plants, meat products (including sausage etc), vegetables, fruits, rice etc. (Quarantine inspection is required prior to Customs inspection.)

Duty-Free Allowance (excluding crew member)

- · 3 bottles (760ml/bottle) of alcoholic beverages,
- 400 cigarettes (If you are a Japanese resident, please contact a Customs officer)
- * There is no duty-free allowance for alcoholic beverages and tobacco products for those under 20 years old.
- · 2 ounces of perfume
- . Goods for personal use that were purchased abroad with a total market value not exceeding \$200,000.
 - * As for children under 6 years old, duty-free allowances are limited to the articles owned for their personal use.
